

# Terms and Conditions

## Street Legal AZ, LLC – Course Requirements

**Refunds / Rescheduling:** PayPal transactions fees will not be refunded  
Cancellation will be subject to a 25% administrative fee.

- 5 – 10 days prior to course date, 50% will be refunded.
- 2 – 4 days prior to course date, 25% will be refunded.
- Rescheduling 2 – 10 days there is no fee.
- Rescheduling 1 day prior to session date is subject to a \$50.00 fee.
- Rescheduling 0 business days prior to session date is subject to a \$75.00 fee.

**Forfeiture of Tuition:**

- Any participant who fails to attend their scheduled drive times without calling Street Legal AZ, LLC prior to their start time and the Instructor is waiting will have a \$75.00 charge applied to their next drive time; payable to Street Legal AZ, LLC.
- If Street Legal AZ, LLC should cancel any portion a rescheduling fee will not apply.

**Required Documentation / Be Prepared:**

- We drive in both rain and shine, so be prepared.
- Permit must be with student at all time during driving sessions.
- Have an understanding of rules of the road and right of ways.

Driving a car requires physical stamina, motor coordination and mental alertness. Be sure you get a good night's sleep before all sessions for the behind the wheel. Do not drink any alcoholic beverage (for adult drivers) or take any medication or drugs that may impair your ability to operate a vehicle safely.

If you are under a doctor's care or have any physical or mental conditions which could affect your ability to operate a vehicle safely, PLEASE tell the Instructor prior to the start of your drive times. Failure to complete a course due to a medical condition that the training facility; Street Legal AZ, LLC was not aware of will result in the loss of your tuition.

**Be Prompt:**

- It is best to arrive 15 minutes before all classes (classroom/ driving). We need to start on time. If you should be more than 15 minutes late, you will be asked to reschedule the class and be charged for a rescheduling fee of \$75.00.
- If you call 48 hours before your drive time a rescheduling fee will not apply.

**Course requirement to waive MVD road test:**

- The State of Arizona requires 100% attendance of all sessions in order to successfully complete the course of 10 hours or more.
- You will be required to demonstrate a road test.

- Passing attains a Training Certified Certificate (TCC) that you will take to the MVD to waive the road test. MVD has the right to retest any of Street Legal AZ, LLC students for QA.

We cannot guarantee that you will successfully complete or pass this course or that you will be able to drive safely enough to be allowed to continue in all of the driving sessions.

There may come a time where either you or the RiderCoach may drop you from the course; this is done in two ways:

- You are operating in a unsafe manner
- Or you are not meeting MVD course standards

When this is the case, there will be no refund of tuition and you will not be able to participate in the driving sessions. As mention above we cannot guarantee your success.
